

What is the Sons of Confederate Veterans?

The citizen-soldiers who fought for the Confederacy personified the best qualities of America. The preservation of liberty and freedom was the motivating factor in the South's decision to fight the Second American Revolution. The tenacity with which Confederate soldiers fought, underscored their belief in the rights guaranteed by the Constitution. These attributes are the underpinning of our democratic society and represent the foundation on which this nation was built. Today, the Sons of Confederate Veterans is preserving the history and legacy of these heroes, so future generations can understand the motives that animated the Southern Cause.

The SCV is the direct heir of the United Confederate Veterans, and the oldest hereditary organization for male descendants of Confederate soldiers. Organized at Richmond, Virginia in 1896, the SCV continues to serve as a historical, patriotic, and non-political organization dedicated to insuring that a true history of the 1861-1865 period is preserved.

Membership in the Sons of Confederate Veterans is open to all male descendants of any veteran who served honorably in the Confederate armed forces. Membership can be obtained through either direct or collateral family lines and kinship to a veteran must be documented genealogically. The minimum age for full membership is 12, but there is no minimum for a Cadet membership.

TAMPA CHOSEN FOR NEXT YEAR'S VET ENCAMPMENT

QUINCY, Fla. Oct 18 — (By the Associated Press)—General J H. Harp was re-elected commander and Tampa selected as the place for the next annual encampment of the Florida division, United Confederate Veterans, at the closing session here today of the thirty third annual reunion. Next year's reunion will be held some time in October, but the exact date was not fixed.

The Sons of Veterans re-elected Dr. Sumner L. Lowry, of Tampa, as commander, and John G. Rearson as adjutant general.

Prior to adjournment about noon, resolutions were adopted by the veterans memorializing members of the organization who have died since last year's encampment and commending State Comptroller Amos for the interest he has taken in behalf of the veterans in getting out their pension vouchers promptly each month. A resolution also was adopted thanking the people of Quincy for entertaining the veterans.

Dinner was served again today by two men of Quincy in a tent on the courthouse yard, after which the veterans began departing for home, many leaving on the east-bound train.





Honorable Jefferson Davis



Originally, **Jefferson Davis** had represented Mississippi in the United States Senate and House of Representatives, but during the War between the States he became the president of the Confederacy.

Arrest and Imprisonment (1865-1867)

Immediately after the Lee's surrender at Appomattox in April 1865, Jefferson Davis fled Richmond, Virginia. He was eventually captured on May 10, 1865, at Irwinville, Georgia, and taken into custody by Union forces. President Davis was charged with treason and conspiracy against the United States and was imprisoned at Fort Monroe, Virginia.

No Trial and Release (1867-1869)

In 1867, President Davis was to be put on trial for treason and conspiracy against the United States. Salmon P. Chase, 1866, Chief Justice of the US Supreme Court opined that, "If you bring these Confederate leaders to trial, it will condemn the North, for by the constitution secession is not rebellion."

There was no trial. President Davis was ultimately released on May 3, 1869.

Post-Imprisonment Life (1869-1889)

After his release, President Davis returned to his home in Beauvoir, Mississippi, where he spent the rest of his life.

President Davis remained active in politics and continued to advocate for the rights of Southerners. He also wrote several books, including a memoir about his time in prison and a history of the Confederate States of America.

After a denial for a marker from the Veterans Administration, an appeal, and another denial, private funds were used to purchase a marker for him.

Purpose: The purpose is designed to honor the memory of our Confederate ancestors and through its implementation will provide the preservation of their final resting places and will document for future generations their sacrifices.

Eligibility: Any Florida Division camp member, Friend of the SCV, UDC, or OCR member, in good standing, who is at least 12 years of age, and who has demonstrated the desire and ability to serve as a GUARDIAN. All compatriots are encouraged to participate in the program to honor our ancestors and to protect their final resting place.

Duties & Responsibilities:

- A. You shall care for and protect the grave of a Confederate Veteran, ensuring that the gravesite is kept clean and well-maintained year-round. You shall perform these duties personally unless you are physically unable because of health reasons. At no time shall these responsibilities be passed on to another without the approval of the GUARDIAN committee for the Florida Division.
- B. You will be responsible to appropriately mark the grave, so it is designated as the final resting place of a Confederate Veteran. This can be by stone, plaque, Cross of Honor, etc. You will also be responsible for replacing or repairing any marker that is worn, damaged or destroyed.
- C. You shall personally visit the grave a minimum of four times a year to include Confederate Memorial Day or at least a week prior. You shall place a wreath, a small Confederate flag or both on the grave.

Applications, Reviews & Approval:

- A. Individuals who wish to participate in the GUARDIAN program must complete and submit the Guardian Application Form to a Camp Commander, or UDC / OCR Chapter President. The Camp Commander, or UDC / OCR Chapter President will submit the form to the Guardian Committee of the Florida Division. The application must be accompanied by a map showing the location of the gravesite along with written driving instructions to the cemetery. A photograph of the gravesite must be submitted before approval. Additional photographs can be submitted for the file as cleanup work is completed.
- B. The applicant must also remit a one-time \$10.00 fee with the application to cover the cost of the GUARDIAN pin and certificate, which will be awarded upon the candidate's approval for membership in the GUARDIAN program. The fee is non-refundable.
- C. Individuals who are not accepted into the GUARDIAN program will be given an explanation in writing by the review committee. The applicant can request an appeal of the decision. The Review Committee will review the applicant's appeal and render a decision. The decision of the Review Committee is final.

Additional Information:

- A. <u>Multiple Gravesites:</u> GUARDIANS may care for more than one gravesite and will be recognized by the Guardian Review Committee. The cost of additional certificates is \$3.00 each.
- B. <u>Forfeiture of Guardian position:</u> A Guardian who cannot meet the requirements of the position due to relocation, health or other reasons must notify the Review Committee. All fees are non-refundable.
- C. <u>Bequeathing of GUARDIAN position:</u> A Guardian may transfer his responsibilities as a Guardian to another Guardian, SCV member, Friend of the SCV, UDC, or OCR member in good standing, with prior approval by the Review Committee. There is a \$10.00 fee for transferring Guardianship. This fee will cover the new Guardian's membership pin and certificate. If they are already in the Guardian program, there will be a \$3.00 fee to cover the certificate designating the new guardianship they are undertaking.
- D. <u>Revocation of GUARDIAN status</u>: The Review Committee may revoke the status of a participant in the Guardian program if they fail to carry out the duties and responsibilities as outlined. The committee reserves the right to inspect any GUARDIAN'S Confederate Veteran's gravesite, with or without notice, to confirm compliance with all the rules and regulations specified in the program.
